Dear Community Supporter:

We are proud to announce the 6th Annual Jazzin' on Jefferson, scheduled for June 27th of this year. The event will again be produced by the Jefferson East Business Association (JEBA). Whether you have participated in the past or not, you are in for an exciting day. Over 15,000 people are expected to attend on that Saturday between 11am and 9:30pm.

Our festival attracts visitors from throughout the metro area. From young to old, the festival has activities for the entire family. In addition to our multiple stages we feature family activities, shopping, an art gallery, home tours and a variety of food and drink.

We invite local developers and development agencies to join us at this festival. One or more tents will be set up with tables available to accepted organizations. Non-profit groups are eligible for a subsidized rate.

Non Profit Organizations- If you represent a Michigan non-profit organization you may be eligible for a table at the festival for our cost of \$100. Since space is limited submitting an application does not assure you of space. Due to city vendor licensing requirements, organizations in this category may not sell any products or services on site. *As an added bonus, we will list each participant with a link to their website on the Jazzin' on Jefferson website.*

Developers- Developers with projects in the Jefferson East area are invited to showcase their available properties at a table for \$300. JEBA will select a limited number of developers depending on space and your application postmark will be considered in the acceptance process. *As an added bonus, we will list each participant with a link to their website on the Jazzin' on Jefferson website.*

Others- JEBA also has space for retail sales, artists, and food vendors. These spaces are not subsidized. Information about these booths can be found by calling Denise Latten at 313-525 7154.

JEBA provides security, two chairs and one table inside a shared tent. As we confirm participation, we will send out further information pertaining to parking, marketing and booth location. Additionally, we plan to host information sessions where we will distribute a map, badges, and marketing materials.

Hold Harmless

The Undersigned Vendor In Consideration For Being Allowed To Participate In This Event Agrees To Indemnify And Hold Harmless Jeba And Its Assigns, Agents, Servants And Employees From Any And All Claims Or Causes Of Action Which Arise By Reason Of Any Act Or Failure To Act On The Part Of Vendor. This Indemnification And Hold Harmless Provision Applies To Any And All Liability Which May Arise From The Vendors Acts Including But Not Limited To Any Loss, Or Damage To Property Or Personal Injury, Which May Be Sustained By Any Individual Or Other Entity At The Event.

Insurance

During The Term Of This Agreement And Any Extension Or Renewal Thereof, Vendor Will Obtain And Maintain Comprehensive General Liability Insurance, Including Person Injury Liability And Property Damage Liability Coverage (And Including Contractual Liability Insurance For The Indemnification Provision Of This Agreement), Which Shall Include Coverage For Any And All Damages, Injury Or Loss Arising Out Of, Resulting From Or In Any Way Connected With Vendors Participate In Jazzin' On Jefferson. The Amount Of Coverage Required Under This Provision Shall Be No Less Than \$1,000,000. Such Insurance Coverage Shall Be Purchased And Maintained At A Reputable And Appropriate Insurance Company. 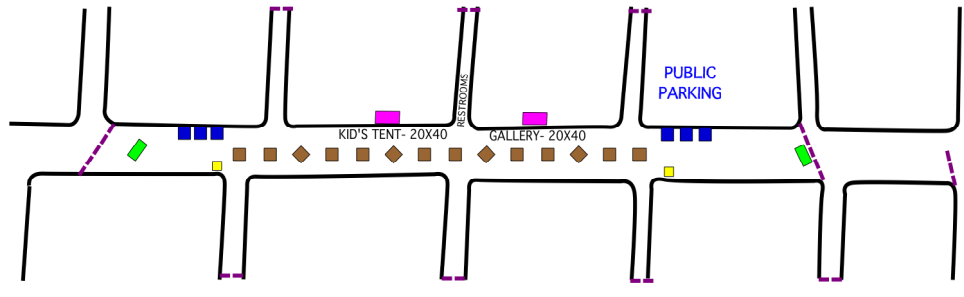
