Rules

Hold Harmless

The Undersigned Vendor In Consideration For Being Allowed To Participate In This Event Agrees To Indemnify And Hold Harmless Jeba And Its Assigns, Agents, Servants And Employees From Any And All Claims Or Causes Of Action Which Arise By Reason Of Any Act Or Failure To Act On The Part Of Vendor. This Indemnification And Hold Harmless Provision Applies To Any And All Liability Which May Arise From The Vendors Acts Including But Not Limited To Any Loss, Or Damage To Property Or Personal Injury, Which May Be Sustained By Any Individual Or Other Entity At The Event.

Insurance

During The Term Of This Agreement And Any Extension Or Renewal Thereof, Vendor Will Obtain And Maintain Comprehensive General Liability Insurance, Including Person Injury Liability And Property Damage Liability Coverage (And Including Contractual Liability Insurance For The Indemnification Provision Of This Agreement), Which Shall Include Coverage For Any And All Damages, Injury Or Loss Arising Out Of, Resulting From Or In Any Way Connected With Vendors Participate In Jazzin' On Jefferson. The Amount Of Coverage Required Under This Provision Shall Be No Less Than \$1,000,000. Such Insurance Coverage Shall Be Purchased And Maintained At A Reputable And Appropriate Insurance Company. Vendor Shall Name Jeba As An Additional Insured Of Said Property And Provide Jeba With A Certificate Evidencing Such Insurance Coverage At Least 10 Days Prior The Event.

Independent Contractors

Vendor And Jeba Are Independent Contractors And This Agreement Is Not Intended To And Shall Not Be Construed To Create A Joint Venture Or Partnership Between The Parties To This Agreement Or To Constitute Either Party As The Agent To The Other Party.

Agreement
